A MESSAGE FROM TOMMY...

As we near the end of 2023, it's a great time to start thinking about our plans for the new year. Have you thought about how you'll vote in the upcoming 2024 elections?

The Presidential Preference Primary (PPP) will take place on March 19, 2024, which is just five months away. While the elections office is putting in great effort to make the voting process smooth and efficient, it's your responsibility to ensure your voice is heard by being election-ready!

To make sure you receive accurate election materials, it's important to have your voter information up-to-date. You can check your status and update your address, name, signature, and party affiliation at www.lee.vote. Having your most current signature on file with the office is vital if you vote by mail.

You have the right to decide which method of voting is best for you, whether it's Vote-by-Mail, Early Voting, or voting at the polls on Election Day. Each one requires responsibility on your part as an engaged voter.

I encourage you to request your Vote-by-Mail ballot now. Not only is this the most convenient way to vote, but it can also be your backup plan if you cannot vote in person.

Early Voting is also a great option as it provides more flexibility. Unlike Election Day, you are not restricted to voting at your designated precinct. Instead, you can choose to vote at any of the twelve Early Voting locations, which will be open daily from 10:00 a.m. to 6:00 p.m.

Did you know that Florida is a closed primary state? To be eligible to vote for a partisan candidate in the March 19, 2024, PPP and the August 20, 2024, Primary Election, you must be registered with one of Florida's two major political parties: Democrat or Republican. You can change your party affiliation with our office up to 29 days before an election.

If you have any questions or concerns, please don't hesitate to reach out. Your vote matters, and I'm here to help make sure you're prepared for the 2024 elections!

Our office is actively working to ensure voters are aware they must submit a new Vote-by-Mail request if they plan to vote by mail in 2024.

On August 31, we mailed approximately 150,000 notices to registered voters informing them their Vote-by-Mail requests had expired. The notice was sent to registered voters who had requested a Vote-by-Mail Ballot for the 2022 General Election but had not yet submitted a request for the 2024 election cycle.

We encourage you to act now and submit your request before the new year to ensure you get your ballot in a timely manner.

Submit your request online, by phone (239) 533-8683, by mail, e-mail, fax, or in person at any one of our branch office locations. New requests are valid through December 2024.

We are grateful for the libraries and all the wonderful individuals who engaged with us! We look forward to celebrating again during next year's 2024 election cycle!



HAPPY RETIREMENT!

On September 23, 2023, Supervisor Tommy Doyle, along with staff, family, and friends, gathered to celebrate the retirement of Lee Carr, the Chief Deputy of Operations.

Lee Carr served the voters of Lee County in various roles since 1989. She played a significant role in facilitating the transition from the punch-card voting system to the iVotronic touchscreen system in 2001 and then in 2008 to the optical scanners still in use today.



One of Lee's most notable achievements was securing the current site of the Election Center. She had envisioned a building that was large enough to accommodate all the voting machines, polling equipment, and classrooms for poll workers' training. One that could also serve as a branch office, an Early Voting site, and an Election Day polling place.

She was honored as a visionary, a mentor to her employees, and a good friend. We wish her a happy, healthy, and fun-filled retirement!
