A MESSAGE FROM TOMMY...

With the 2022 election cycle behind us, we now look to this year's municipal elections. On March 7, our office will conduct the City of Sanibel and Village of Estero Regular Election for their Councilmembers.

Our office assumed the responsibility of managing Candidate Qualifying for the Village of Estero. Candidates submitted their qualifying paperwork the week of January 9 through January 13. The City of Sanibel's candidates submitted their qualifying documents to the City of Sanibel's City Clerk.

Residents of these municipalities will vote for their city council members. Councilmembers provide leadership, determine policies, and manage the city's finances, among other essential responsibilities. [Click here](#) to view the respective candidates.

I have an important reminder for all voters. Under Florida law, all Vote-by-Mail requests expired at the end of 2022. You must submit a new request if you plan to vote by mail in a municipal, primary, or general election through 2024. [Click here](#) to request a Vote-by-Mail ballot. The deadline to request a Vote-by-Mail Ballot for the Sanibel and Estero elections is 5 p.m., Saturday, February 25.

MARCH 7 MUNICIPAL ELECTIONS



In Florida, every election must have a Canvassing Board present to oversee the election process.

In municipal elections, the Canvassing Board consists of the Supervisor of Elections, a municipal Councilmember and their respective municipal Clerk.

Their duties include, but are not limited to, overseeing all public pretesting of the tabulation equipment used in an election, canvassing Vote-by-Mail and Provisional Ballots, certifying an election, and conducting post-election manual audits.

Logic and Accuracy Testing

On Wednesday, February 15, our office conducted a public Logic and Accuracy Test (L&A) for the upcoming City of Sanibel and Village of Estero Regular Elections.

By state law, this test must be completed before every election to ensure ballots are printed correctly and the voting equipment is counting votes accurately.

Smaller-scale elections, such as municipal elections, must adhere to the same election laws and protocols applied when conducting major elections.

The L&A was overseen by the Canvassing Boards for the City of Sanibel and Village of Estero Regular Elections.



Poll Worker Training

Poll workers are the backbone of every election. Our office relies on poll workers to provide superior election services to voters during Early Voting and on Election Day.

Florida state law mandates all poll workers must have training before each election. Poll Worker training classes for the upcoming March 7 City of Sanibel and Village of Estero Regular Election begins on February 28.

Poll Worker training includes videos on “Conflict Management Skills for Election Workers” and “Serving Voters with Disabilities” to help provide poll workers with the tools to deliver the best voting experience for our voters.
