The March 17 Presidential Preference Primary (PPP) is a partisan Republican and Democratic Primary ONLY, therefore, only voters who are registered Republican or Democrat are eligible to vote for presidential candidates.

The last day to register to vote and change your party affiliation for the PPP is Tuesday, February 18.

Click here to check your voter registration status to make sure you are registered and registered with the correct party affiliation.

If you have not requested your vote-by-mail ballot, I strongly suggest you do it now. It is the most convenient way to vote and we pay the return postage. The last day to request your vote-by-mail ballot is 5 p.m. Saturday, March 7.

ELECTION CENTER HAPPENINGS

BALLOT PROGRAMMING FOR ELECTIONS

It takes an incredible amount of teamwork to orchestrate an election. Each department strives to fit their part seamlessly into the framework of laws provided by the federal, state, and local government that guide us through the elections process.

Ballot programming is an essential part of that process because a ballot is the tool used to cast a vote.

This process begins with ensuring the voter's information contains their current address to determine voter placement within the appropriate precinct boundaries by our Geographic Information System Specialist, Sharilynn Domain.

It is imperative that ballots contain all the necessary information: candidates, amendments, and referendums

that fall within each district of our county.

Where you live determines what is on your ballot. District lines such as fire districts, county commission and precinct boundaries all play a role in a voter's ballot style.

As soon as our staff receives this information, they are able to move forward with ballot programming.

Cybersecurity continues to be a top priority at Lee Elections. All Supervisors of Elections across the state of Florida work in partnership with Florida Secretary of State, Laurel Lee, FBI, Department of Homeland Security, MS-ISAC, and EI-ISAC, to ensure the highest security measures are in place to protect voter information and the integrity of elections in Lee County.

ELECTION CENTER HAPPENINGS

POLLING LOCATION SELECTION

The selection of polling locations for Early Voting and Election Day is a critical step when preparing for any election. Each Supervisor of Elections must follow Florida and Federal laws during the selection process to ensure optimal safety and accessibility for voters and poll workers.

The facility must comply with the Americans with Disabilities Act and be accessible for all voters to enter and exit the same route. Parking must be sufficient to support voter traffic. The area must be of sufficient size to support our setup and voter traffic, and must have sufficient lighting and electrical outlets to power equipment.

Not all locations can become polling locations or are available for use. A polling place with non-compliant elements that cannot be remedied with permanent or temporary measures cannot be used.







Last year was an excellent year for physical security upgrades at Lee Elections. Our Elections Center branch office had additional security cameras installed throughout the perimeters and inside the facility. We now have a Lee County Deputy on-site at every one of our branch offices to increase security measures.

Below are a few highlights from 2019.










GOODWILL FESTIVAL OF TREES
